



Public Disclosure of Willful Loan Defaulters

This publication is made pursuant to Notice No. **BG/GOV/SEC/2025/23** issued by the Bank of Ghana, which requires Regulated Financial Institutions to publish, on a semi-annual basis, the names of customers classified as Willful Defaulters.

In compliance with **Part II, Section 17** of the Notice, Access Bank Ghana will publish its list of Willful Defaulters on the 30th of June 2026 in two national newspapers and on its official website.

Regulatory Consequence:

Borrowers named as Willful Defaulters two (2) or more times within ten (10) years shall be subject to a mandatory five (5) year ban from accessing credit facilities within the banking sector, or a longer period where applicable under the regulatory framework.

Customers are strongly advised to regularize their outstanding obligations immediately to avoid further regulatory, financial, and reputational consequences.
